TOPO TEMPS PRIVACY POLICY

(Date of Last Revision: September 3, 2019)

The website <u>topotemps.com</u> (the "Site") and the Topo Temps application (the "App," the Site and App are collectively referred to herein as the "Application")) are owned and operated by Topo Temps, LLC (collectively, "Topo Temps," "we," or "us"). The Application provides content and services listed on topotemps.com (the "Services").

By using the Services, you consent to the data practices described in this Privacy Policy. This Privacy Policy does not apply to the practices of companies that we do not own and/or control or to people that we do not employ or manage.

We collect your information only when you provide it to us and we collect only the minimum amount of information necessary. We do not sell or rent your information to third parties.

Information We Collect

We may collect the following information from you when you use the Application or when the Application is running in the background of your electronic devices:

- We collect your "Personal Information", which means your name, image or likeness, geolocation, gender, age, payment information such as credit card numbers, and similar personally identifying information that you choose to provide to us when you contact us to request information regarding our products, when you purchase products, or when you otherwise use the Services.
- We collect your contact information including your name, address, shipping address, email, phone number, and country and state of residence when you choose to provide that information to purchase a product or service.
- We collect analytical information such as the time of your visit, pages visited, and time spent on each page of the webpages; referring site details; network location; products you viewed, browser type, operating system, IP address, and device information ("Analytical Information").
- We collect location-specific weather data associated with your geolocation, including altitude, and the temperature, pressure, humidity, dew point, and heat stress of your location ("Weather Data"). We only collect Weather Data when you actively consent to us collecting this information.
- We collect your user photos and other uploaded content such as trail photos, trail ratings, and trail comments ("User Generated Trail Data").
- We may also collect information you provide in voluntary surveys about the performance of our Services.
- We purchase or collect commercially available personal information from third parties, including when you choose to participate in a third-party application or features such as one of our social media pages or a similar application or feature on a third-party website. If you make a purchase using the Application, we will use third-party payment processors to process the transaction. As such, the collection and use of your financial data is governed by the terms of use and privacy polies of the third-party payment processor. In the U.S., we use the Apple App Store and you can

Interest-Based Ads

How We Use Your Information

We use your Personal Information to provide you the Services, and to receive and respond to your inquiries about products, services, warranties, or support. To address your questions, we may subsequently need to request additional information. We may use your Personal Information to contact you about products or services of Topo Temps that we believe may be of interest to you.

We use and publicly display Weather Data and User Generated Trail Data to improve your user experience and that of other users.

When you use the Services, we automatically collect and use Analytical Information in order for us to track your movement on the Application to improve our layout and page arrangement, get information on your browser type to ensure our Application remains compatible with the browsers used by our customers, improve your experience with our Services, and to promote Topo Temps' Services. We use your Analytical Information in the aggregate to determine market trends and trends in customer behavior.

Information Sharing and Disclosure

We may share your Personal Information to provide a product or service you have requested.

We may share your Personal Information with service providers that perform tasks on our behalf related to our business, such as order fulfillment services, analytical services, book-keeping services, marketing services that may provide you advertising on our behalf, customer service, employment services, or social media services.

We may disclose your Personal Information as required or appropriate by law, including to comply with legal process and to respond to requests from public and government authorities; to enforce our terms and conditions, including investigations of potential violations thereof; to detect, prevent, or otherwise address fraud, security, or technical issues; and to protect our operations.

We may share or disclose your Personal Information with your consent.

Your Personal Information may also be shared with a company that acquires our business, whether through merger, acquisition, bankruptcy, dissolution, reorganization, or other similar transaction or proceeding.

Your Choices

We store your information for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer period is permitted or required by law.

If you choose to delete your account, your information may remain in our databases, but will no longer be connected to your user profile.

Cookies

We use "cookies," a small text file transferred to your device, along with similar technologies (e.g., internet tag technologies, web beacons, embedded scripts) to help provide you a better, more personalized user experience. These technologies are used to:

- Make the user experience more user friendly;
- Remember your preferences (e.g., browsing language, usage preferences); or
- Help us understand and improve how visitors use our Application, including which of our pages and products are viewed most frequently.

The Options/Settings section of most internet browsers will tell you how to manage cookies and other technologies that may be transferred to your device, including how to disable such technologies. You can disable our cookies or all cookies through your browser settings. Please be advised that disabling cookies through either method may impact many of the features of the Application.

We use the following cookies:

- Strictly necessary cookies that are required for the operation of our Application
- Analytical/performance cookies that allow us to recognize and count the number of visitors, see how visitors move around our Application, and help us improve the way our Application works
- Functionality cookies that enable us to personalize our content for you
- Targeting cookies record your visit to our Application, the pages you have visited and the links you have followed.

The use of third-party cookies is not covered by our Privacy Policy. We do not have access or control over these cookies. If you continue to use our Application, we will assume you agree to the use of these cookies.
